1. WELCOME

- CG opened the meeting and welcomed CCC members and new member DM.
- GM introduced CC and AT.
- GM advised the CCC members that David Bennett (DB) was appointed General Manager of MTW in mid March 2021, after acting in that role for some time. GM noted that DB could not attend the meeting today, but DB had attended many CCC meetings over the years so has an existing relationship with the CCC.
- GM noted that the site tour that was offered to all CCC members was attended by DM and AG, and was a useful overview with visits to parts of the operations, rehabilitation areas and offsets.

7. PROPONENT REPORTS AND OVERVIEW OF ACTIVITIES

MTW Operations

Refer to presentation

• HJ enquired the location of the draglines in pit and whether there was any additional dust suppression or controls in place for the draglines, given the close vicinity to the Mount Thorley Industrial Estate. CC identified locations on aerial map and GM advised that standard practices of OCE and operator inspections as well as intermittent dust delays were sufficient controls in mitigating any potential dust issues.

Monitoring

Refer to presentation for data - January to April 2021

- GM presented equipment downtime / Community Response Officer noise assessments and operational changes for nights above noise limits and outlined that while downtime was predominantly dust related, this was shifting with the cooler nights and the presence of temperature inversions.
- SM discussed the issues surrounding temperature inversion, and noted he experienced amplified noise on nights with a temperature inversion present, which he believes impacts noise reading results. SM advised that in recent years he had requested a list of days in which temperature inversion was recorded and consequently noise readings would be disregarded. SM noted this should be investigated further. SM also noted that Community Response Officers (CRO) are not present early mornings to help mitigate noise impacts on the community.
- GM advised that MTW still reacts to internal noise triggers which still occur whether temperature
 inversions are present or not. GM advised that CROs routinely and reactively complete readings
 throughout the night. GM advised the external noise consultant, however, will factor in temperature
 inversion when applying noise limits on compliance readings.

- DM enquired as to why many of the noise readings are classed inaudible on the Insite webpage, and whether other interferences such as wildlife are contributing to a reading not being taken. DM queried the monitoring location on Wambo Road and whether this location could be moved now that several residences along Wambo road are MTW owned.
- GM advised that for readings classed as inaudible, mining operations are not audible. GM noted that sometimes readings are not taken due to other interferences, and the CRO then moves onto a different monitoring location. GM outlined that monitoring is completed in a location representative of a large group of people, and these locations are dispersed around the operation.

Hunter River Salinity Trading Scheme (HRSTS) Discharge

Refer to presentation

- GM provided an overview of the process for licenced discharges under the HRSTS program and noted that Mount Thorley Operations (MTO) enacted a licenced discharge in accordance with the HRSTS in March -April 2021, after receiving significant rainfall during 2021. GM noted this is the first time a licenced discharge has been enacted since 2016.
- SM queried whether both WML and MTO discharge at the one point into the Hunter River. GM confirmed that both MTO as well as a surrounding mine site, discharge into Loders Creek. WML did not undertake a discharge, however WML would discharge into Doctors Creek which joins Loders Creek prior to it reaching the Hunter River. GM outlined that different 24hr blocks are allocated for different sites.
- NH queried if Loders Creek is purged after discharge. GM outlined the discharge must comply with parameters for water quality during discharge and confirmed that no purging is required after discharge.

North Out Of Pit Dam (NOOP)

Rehabilitation / Disturbance 2021

- SM queried the parameters of disturbance surrounding Wallaby Scrub Road and inquired when mining would commence across Wallaby Scrub Road. SM also inquired how Crown Land acquisition in that area is progressing.
- GM advised that stripping has already occurred to the east of Wallaby Scrub Road. GM also advised that
 once the Wollombi Brook Cultural Heritage Conservation Area is completed, mining would commence
 over Wallaby Scrub Road. Regarding Crown Land, GM advised that either Section 265 Mining Act
 Agreements were in place with the Crown or land was acquired, which allowed for mining activities. GM
 advised that the intention was for acquisition but would take an action to provide an update.

ACTION 1: MTW to provide an update on the agreements arrangement for Crown Land / Roads within the disturbance area west of Warkworth mine.

Vertebrate Pest Management 2021 Refer to presentation

Weed Management 2021 Refer to presentation

- General discussion around the prevalence of weed species in the area and management strategies was discussed among various members. SM noted difficulty with the management of African Love Grass and noted it's presence in the Bulga recreation area.
- HJ queried whether weed management information was shared with local land services, to which GM replied information was shared on an ad hoc basis.

ACTION 2: In response to an enquiry from SM about African Love Grass, MTW to seek information around MTW management of this weed species and current success rate.

Northern and Southern Biodiversity Area (BA) Planting Program 2021

Historic & Cultural Heritage Management

- SM enquired if a 12 month plan was in place for the historic heritage items in the presentation. SM also enquired where the artifacts removed from an area adjacent to Wallaby Scrub Road were relocated to, and whether these artifacts will be available for public viewing in the future.
- GM advised that MTWs focus was to address the immediate actions that were raised in the compliance inspection, and then look at a more detailed plan. GM noted the artifacts were in an undisclosed location and advised that a dialogue would need to occur with the Aboriginal parties regarding accessibility in the future.
- NH enquired about the area of Loders Creek Cultural Heritage Conservation Area and the activities taking place in this area. GM advised that Loders Creek Cultural Heritage Conservation Area will be become priority once Wollombi Brook Conservation Area is completed.

ACTION 3: In response to a query from NH, MTW to provide details on the location and activities in Loders Creek Cultural Heritage Conservation Area.

Business Papers

Business papers were provided to CCC members prior to the meeting, including a summary of; Complaints, Incidents, Environmental Monitoring, Rehabilitation, Website Uploads and Community Investment Update. MTW Monthly Environmental Monitoring Report (MEMR) for December 2020, as well as January and February 2021 were provided.

- SM noted that the December 2020 MEMR was nearly six months delayed and therefore becomes absolute. He queried why this was not available at the last CCC meeting, and advised it seems worthless to raise issues so far down the track. SM queried whether the surface water section of monthly reports could be separated to ensure other information became available sooner.
- GM acknowledged the report was delayed due to several factors, including significant rainfall events, annual reporting and the inclusion of surface water monitoring sections within these reports. GM advised he would take SM's suggestion of separating surface water under consideration.
- General discussion around the number of complaints was discussed amongst members. GM outlined complaints had decreased in comparison to previous years. DM advised that complaint numbers could be impacted by property acquisition.
- General discussion regarding the status of acquisition of properties with acquisition rights in the development consents, and a request was made for status of acquisition.

ACTION 4: MTW to provide status on property acquisitions by the mine with respect to properties with acquisition rights in the development consents.

9. GENERAL BUSINESS

General Business MTW – Lemington Underground Water Storage & WML Workshop

Refer to presentation

- GM provided CCC with an overview of proposal to transfer water to former Lemington Underground mine in conjunction with HVO. This process would be subject to environmental assessment, and modification would be required to WML and HVO consents. WML is also proposing to construct a new workshop near the existing WML workshop to cater for Ultraclass sized trucks, which are commencing to arrive in 2021.
- General discussion occurred surrounding process of water extraction and storage, water quality and volume with multiple CCC members.
- HJ enquired regarding Ultraclass truck size, sound attenuation, and automation. GM / CC advised that the new trucks are have approximately 300t payload, and will be sound attenuated. GM advised that all haul trucks are required to be sound attenuated by the development consent. CC advised that none of the trucks are proposed to be automated i.e. they require an operator.

General Business MTW – MTW Underground (UG) Project

- GM provided a brief update on the commencement of UG EIS early consultation processes regarding the Social Impact Assessment (SIA), which was introduced to the CCC at the previous meeting. Consultation commenced for the SIA scoping with representatives of the Singleton Business Chamber, Singleton Council, and several CCC members.
- SM advised that the consultation process did not leave him with project specific information, so he could
 not comment specifically on the underground project. GM advised that the SIA consultation was only to
 scope the SIA process i.e. who should be consulted during the SIA, and not intended to seek particular
 comments on the project itself. GM advised that MTW is therefore not currently leaving project
 information in the public domain or publishing that information as yet, that would happen in the future,
 and that comments can be made in future consultation on the UG project.

General Business MTW - Community Support Program (CSP)

General Business - CCC Members

- NH provided the CCC with general historical information on Philip Thorley, for whom Mount Thorley is named.
- DM advised that the general community is unhappy with MTW blast management, especially in concern
 to blast notification and road closures. DM enquired whether a meeting could be set to discuss
 community concerns. GM agreed that blast management and road closures was often discussed in the
 CCC forum. GM outlined changes to blast notifications made recently and happy to receive further
 feedback on this and other aspects of the Blast Management Plan processes. GM noted that MTW takes
 its Blast Management Plan and Road Closure Management processes very seriously and is acutely aware
 of its responsibility to manage the impacts within development consent limits for vibration and
 overpressure, management of fly rock exclusion zones, and to manage blast emissions.
- DM enquired about underground mining opportunities and the prospect of further mining extensions. GM advised that underground mining project feasibility and exploration and the progression to early works for an underground project EIS has been discussed in the CCC forum. GM advised that for the open cut the development consent permits mining up to 2037 up to the disturbance limit of the constructed rural fire service track. GM advised that as a resources company, options within the mining leases are continuously explored.
- SM expressed community concern with blast management at MTW, with reference to blasting activities in February 2021. SM discussed previous action taken by MTW to reduce impacts to the community, including changing blasting techniques to electronic detonation. SM advised that community has had to deal with blasting impacts for more than 30 years, requested a meeting at local level to discuss MTW blasting.

ACTION 5: MTW to invite CCC to separate meeting to discuss Blast Management Plan / Road Closure Management Plan processes.

• SM enquired whether Community Heritage Advisory Group (CHAG) meetings should be held annually and questioned why these meetings had not occurred in recent years. GM advised that is not a requirement for these meetings to be held annually in the consent, and meetings will be held when there is a reason for a meeting to occur. CG requested clarification on the requirements for CHAG meetings to be held.

ACTION 6: In response to enquiry from SM, MTW to provide clarification on the need for and frequency of CHAG meetings with respect of development consent processes.

• SM enquired about heritage funds specified in the development consent. GM advised that for the Great North Road, that the Convict Trail Project, have been provided the funds for the Great North Road project. They are lagging behind on their project progression at present. MTW has a partnering agreement Singleton Council for the MTW Historic Heritage Conservation Fund, and has been providing funds to council for that. Council administers the applications and advertising for the funds.

ACTION 7: MTW to provide details of relevant contact at Singleton Council regarding MTW Historic Heritage Conservation Fund.

- SM advised he had observed traffic and signage issues along the Putty Road at the entrance to the closed former Wallaby Scrub Road, and this entrance should not be in use by the mine. GM advised that as it is not a primary access point, MTW is permitted by its development consent and EIS to use boundary gates for ancillary purposes such as access to shutdown pads. GM noted that that this entrance was used for many years as a publicly accessible road.
- HJ enquired on whether any road signage was removed after the former Wallaby Scrub Road was closed.

ACTION 8: MTW to investigate west bound traffic turning right off Putty Road into shutdown pad and whether signage is appropriate for this entrance.

- HJ stated her strong support for local apprenticeships programs, noting that MTW does offer apprenticeships, but particularly noted that apprenticeships should be for local people, not those out of area.
- HJ noted that Council elections are coming on 4 September 2021.

MTW Operations

- Mining production continued in Warkworth and Mount Thorley Operations.
- MTO: DL 102 has completed the pit drainage filter bed in Loders Pit. This is part of Loders Pit becoming a waste / tailings emplacement.
- WML: DL103 has been working in the lower passes of North Pit while DL 101 is working in the lower passes of West Pit respectively
- WML: Normal load and haul operations have continued
- WML: Water management (sediment basins / catch drains) construction has been completed in both North and West Pit.
- Coal processing and train loading normal operations.

MTW Operations – HRSTS Discharge

- Significant rainfall (237mm) was received in March 2021.
- MTW discharged 703 ML during 16 March 2021 - 6 April 2021 in accordance with Hunter River Salinity Trading Scheme from MTO Licenced Discharge Point 4 (Dam 9S).
- pH marginally exceeded upper limit (9.0) from 26 March 2021, but only after consulting EPA, lodging variation application to increase pH limit (9.5) to be equivalent to neighbouring EPL holders, and agreeing with EPA on protocol for reporting pH when it exceeded the upper limit.
- EPA have advised no further action required and are continuing to assess the licence variation.





MTW Operations – NOOP Dam

- NOOP is an approved dam in Warkworth Continuation Project development consent SSD-6464 and will provide improved water security / balance position at MTW.
- Infrastructure and test blasting initially completed in 2019.
- North Out Of Pit (NOOP) main dam construction is planned within next 2 years.

Lemington Underground Water Storage & WML Workshop

- HVO and MTW are investigating ways to improve site water management across the operations.

4 REHABILITATION PLAN

The rehabilitation planned for 2021 is 41ha, consisting of 35ha Mining Operations Plan (MOP) rehabilitation target for 2021 and the 6ha shortfall from the 2020 rehabilitation target. The 2021 planned bulk shaped polygons and progress YTD are presented in the map below. The planned total disturbance is 46.8ha, which includes 3.8ha of rehabilitation disturbance to construct the North Out of Pit Dam.

At the end of April, there was 8.0ha of bulk shaping that had been completed and a further 12.6ha of dump area that had been released for bulk shaping.

Disturbance completed to the end of April totals 25.2ha and is mainly associated with clearing ahead of mining in West Pit.
