#### WHAT'S HAPPENING AT STRATFORD?

The Stratford Mine site transitioned to closure in 2024. Ongoing mine closure activities, bulk earthworks and reshaping to create the final landform are now progressing as part of the site's rehabilitation.

Our team has recently been focused on several key activities across the site. Topsoiling works are progressing well at Bowens Road North, while bulk earthworks are ongoing at Stratford East. At Avon North, bulk shaping has commenced.

Demolition of the CHPP infrastructure commenced in May this year. The process includes safely removing hazardous materials, clearing out and taking down buildings, dismantling equipment, and recycling anything that can be reused. Concrete foundations are also being removed and stockpiled for disposal.

Large excavators are being used, equipped with tools to cut, grab, and break apart materials.

The demolition is expected to continue until around December 2025.




CHPP - February 2025

## WHAT'S HAPPENING AT DURALIE?

Coal extraction at Duralie ceased in December 2021. Since then, we've been rehandling material, decommissioning infrastructure, maintaining existing rehabilitation, and continuing our environmental monitoring. In the coming months, bulk earthworks will recommence to reshape and rehandle spoil material and complete construction of our final landform.

To support this important stage of mine closure, Yancoal has been actively recruiting for a range of roles, including Mining Supervisors, Maintenance Supervisors, Mining Operators, and Plant Mechanics.

# **UPDATE ON THE STRATFORD RENEWABLE ENERGY HUB (SREH)**



The Project remains under assessment by the NSW DPHI.

Here's an example of how the program is making a tangible difference in the community:

Stratford Coal's Community Support Program has donated \$3,000 to the Booral Rural Fire Service to purchase two medium and one large Lithium-Ion battery fire blankets to safely extinguish intense, toxic fires from phones, laptops, e-bikes and even electric vehicles. Deputy Captain Kathryn Massey says the blankets will help volunteers tackle these unique hazards faster and with less risk to firefighters, residents and the environment.
